### ORDER

- As per paper read first above, the Higher Education (E) Department has issued orders regarding the revision of fee structure of self-financing Arts and Science programmes in Colleges affiliated to Universities in Kerala by enhancing 12% to the existing fee structure from the Academic Year 2024-25 onwards.
- The existing and available Govt. Orders in this University, regarding the fee structures of self-financing Arts and Science programmes in affiliated colleges, which are to be enhanced are referred as paper read from (2) to (6).
- Considering the urgency, as per paper read (7), sanction has been accorded by the Vice Chancellor, to implement the Government Order read as paper (1) above, subject to reporting to the Syndicate.
- Therefore, the G.O.(Ms) No.299/2024/HEDN dated 19-05-2024 cited first above, is implemented in the University, subject to reporting to the Syndicate.
- The enhanced fee structures (by 12%) of various self financing Arts and Science programmes in affiliated colleges, in accordance with the Govt. Orders read from 2 to 6, from the Academic Year 2024-25 onwards, are as shown below.

### ORDER

The fee structure of self-financing arts and science programmes in colleges affiliated to universities in Kerala was revised vide G.O.s read as 1 to 3 above.

2. Associations of various Self Financing Arts and Science College Managements have requested Government to revise the fee structure of self-financing arts and science programmes in colleges. Also, the Hon'ble High Court of Kerala, vide judgments read as 5 to 7 above, directed Government to consider the requests and pass appropriate orders in the matter.

3. In the circumstances, as per the G.O. read as 8th paper above, Government constituted a committee to look into the demands of the

managements of self-financing Arts and Science Colleges for revision of fee structure of self-financing arts & science programmes in affiliated colleges in the State and to report to Government regarding the matter. The Committee recommended a hike of 12% in the existing fee structure of self-financing arts & science programmes in affiliated colleges from the academic year 2024-25 onwards.

4. Government have examined the matter in detail and are pleased to revise fee structure of self-financing arts and science programmes in colleges affiliated to universities in Kerala by enhancing 12% to the existing fee structure from the Academic Year 2024-25 onwards.

5. Further, upon introduction of the Four Year Degree Programme in the State from the Academic year 2024-25, the fee structure of programmes will need to be further revised as per course /credit system. In the circumstances, Government shall consider to constitute a Committee, as and when the necessity arises, comprising of the Registrars of the Kerala, Mahatma Gandhi, Calicut and Kannur Universities as members to suggest a feasible fee structure for the courses and thereupon, a further restructuring of fee of the courses shall be made.
